

# **Privacy Policy**

We, at www.jmfinancialproducts.com, acknowledge and accept that the personal details that you shared with us, is to be kept in strict confidentiality and to use the information only in the manner which would be beneficial to our customers. Your privacy is important to JM Financial. We consider our relationship with you as invaluable and strive to respect and safeguard your right to privacy. This privacy statement provides information about the personal information that JM Financial collects, and the ways in which JM Financial uses that personal information.

We view protection of your privacy as a very important principle. We understand clearly that you and your Personal Information are one of our most important assets. We store and process your Information including any sensitive financial information collected (as defined under the Information Technology Act, 2000), if any, on computers that may be protected by physical as well as reasonable technological security measures and procedures in accordance with Information Technology Act 2000 and Rules made there under. Our policy on the collection and use of personal information and other information is outlined below.

Collection of Sensitive Personal Data or Information:

JM Financial may for the purpose of rendering its services, collect personal information such as:

# Information that you may be providing us directly

- Identification Information: Name, gender, residential / correspondence address, telephone number, date of birth, marital status, email address or other contact information;
- PAN, KYC Status, Signature and Photograph;
- Bank account or other payment instrument details;
- Any other detail for providing services

# Information we may collect from your use of our services

**Transaction Information:** We read SMS to retrieve OTP sent by JM Financial during login or transaction related authentication.

**Storage Information:** We may facilitate user to download and display information which a user may refer to, or to upload relevant documents as per various processes during user account management or transaction order placement.

**Media Information:** We facilitate users to capture / upload relevant documents as may be required to be uploaded during user account management or transaction order placement.



**Device Information:** We collect specific information about your device when you access our Services, including your storage, hardware model, operating system and version, unique device identifier, mobile network information, and information about the device's interaction with our services.

Such information may be collected in a manner that the client is always aware of the collection and purported usage of the same. The client shall have an option to withdraw consent to share the information. However, such intimation shall be required in writing. Such intimation shall only be taken into account from the date on which the same is received. JM Financial may stop Services in case such intimation is received in case the same is required under the regulations. Such information shall only be used for the purpose it is collected.

## **Communications:**

When you use the Website or send emails or other data, information or communication to us, you agree and understand that you are communicating with us through electronic records and you consent to receive communications via electronic records from us periodically and as and when required.
